## DISCIPLINARY RULES

**RULE 1.** These disciplinary rules intend to sanction any violation of these rules or any unsportsmanlike conduct, inside and outside the playing court, which may affect the tournament.

**RULE 2.** The local Catalan teams must be aware that any incidents occurred during an unofficial competition not ruled by the local federation, will be sanctioned by the FCH's Competition and Sports Disciplinary Committee, who will establish any relevant sanctions under request from the third party involved in the incident.

**RULE 3.** Sanctions that can be established according to these rules :

a) Sanctions to players, coaches, assistants, auxiliary staff, officials and management

- 1.- Disqualification/exclusion from the tournament
- 2.- Temporary suspension.
- 3.- Warning.

b) Sanctions to teams.

- 1.- Disqualification/exclusion from the tournament
- 2.- Lost of match or corresponding round.
- 3.- Lost of points in the corresponding round.

**\*Fouls committed by players, coaches, assistants, officials and management and relevant sanctions\***

**RULE 4.** The following fouls are considered to be **very serious fouls**, and will imply **disqualification from the tournament**.

- 1.- Assaulting the referees, officials, and members of the opposite teams, team-mates, or spectators with the result of serious injury.
- 2.- Attacking back when assaulted by another person.
- 3.- Playing with two or more teams in the same category.
- 4.- Carrying out actions that may result in the final suspension of the match or making it impossible to commence.
- 5.- Not following the sanction established because of serious foul.

**RULE 5.** The following will be considered as **serious fouls**, and will be punished with **suspension from four to six matches**.

- 1.- Assault or attack violently any of the referees, officials, members of the opposite team or the same team, or people attending the match even if there is no physical damage or injury.
- 2.- Insult, threaten or humiliate seriously any of the referees, officials, members of the opposite team, team-mates, or spectators before, during or alter the match.
- 3.- Playing a match with a different identity.
- 4.- Damage intentionally the sports hall or anything belonging to another person.
- 5.- Not following the punishments established for any light foul.

**RULE 6.** The following will be considered as **light fouls** implying warning or temporary suspensions **from one to three matches**.

- 1.- Insult, offend, threaten or provoke any of the referees, officials, members of the opposite team, team-mates, or spectators before, during or alter the match.

2.- Unsportsmanlike conduct affecting the match

3.- Repeated protests concerning decisions from the referees.

**RULE 7.** It is forbidden for coaches, assistants or auxiliary team to enter the playing court without authorization from the referee except in cases of force major. Failing to comply with this rule will be punished with warning or temporary suspension from one to three matches.

**RULE 8.** The coach, assistant or auxiliary staff that may order their team to leave the playing court before the end of the match will be sanctioned and disqualified from the tournament.

**RULE 9.** The following will be considered as very **serious fouls** and will imply **exclusion from the tournament**.

- 1.- Fail twice to attend a match without adequate justification.
- 2.- Any fouls incurred by the players, coaches, assistants, officials team management that may be considered to be very serious and applicable to the teams.
- 3.- Offering bribes to the referees with the intention to get a partial arbitration and a favourable result.
- 4.- Agreements between clubs to reach a certain result.
- 5.- Acts of rebellion against decisions made by the tournament organization or the disciplinary committee.
- 6.- Repeated incorrect presence of a player in the court due to negligence of the team management

**RULE 10.** The following will also be considered as **serious fouls** punished with **match lost 10-0 and discount of 2 points in the general classification, or disqualification from the corresponding round**

- 1.- Failure to attend a match or attend with less than 5 players.
- 2.- Team players leaving the court, resulting in suspension of match.
- 3.- Unsportsmanlike attitude of team players resulting in suspension of match.
- 4.- Incidents between spectators that according to the Competition Committee may seriously obstruct the match preventing its finalization
- 5.- Light fouls occurring repeatedly preventing the commencement or finalization of the match.
- 6.- *Incorrect presence in the court of a team player due to negligence of the team management*
- 7.- Lack of truthfulness and/or intended alteration of data given in the list of players and team technical staff.

**RULE 11.** Any claim or protest must be presented by writing together with **a €30 deposit**, maximum 12 hours after the event denounced occurred. This deposit will only be reimbursed should the Competition Committee rule on the favour of the protesting team.

**RULE 12.** Any claim or protest presented to the Competition Committee will show the following information :

- a) Name of the team and the person signing the protest, mentioning position within the team.
- b) Facts justifying the protest and rules on which it is based.
- c) Evidence and proofs related to this protest
- d) Specific claim requested.

**RULE 13.** The ruling of the Competition Committee **will not be final and will not allow any further protest.**

THE COMPETITION COMMITTEE
